EEA nationals

- You can continue to arrive in the UK until 31.12.20 with no visa required
- From 1.1.21 you will be recognised as a non-visa national and will be able to enter the UK as a visitor (using the eGates) and study for a maximum of 6 months.
- You should be able to show you have been accepted on a course of study
- For courses over 6 months you will need to apply for a short-term study visa on-line

Non-visa nationals (not EEA)

- If you are a Non-visa national coming to study for less than 6 months (and cannot use eGates) you will need to obtain an Entry stamp at the airport. For this you will need to present the following to the Immigration Officer at the UK airport.
 - details of where you intend to stay
 - show you have been accepted in a course of study
 - your [tuberculosis \(TB\) test results](#) if applicable
 - contact details for at least one parent or guardian in your home country (if under 18)

If you're under 18 and travelling without your parent or guardian, contact details for at least one parent or guardian in your home country and any [extra information to show they've given you permission](#).

You must always have these documents with you if you're travelling in and out of the UK during your stay.

Visa nationals, If you' are over 16 years old you must [apply online](#):

- **Visitor visa** - if your course is up to 6 months (within application you will be asked to select Main reason for your Visit to the UK, where you will select option Studies up to 6 months)
- **Short-term study visa** if your course is 6-11 months – please note you are unable to switch to a non-Kaplan school once you have received your visa

What documents you must provide when applying

- a current passport or other valid travel identification & one [passport-sized colour photograph](#)
- evidence that you can support yourself during your trip, eg bank statements or payslips for the last 6 months
- details of where you intend to stay and your travel plans
- your [tuberculosis \(TB\) test results](#) if you're from a country where you have to take the test
- contact details for at least one parent or guardian in your home country (if you're under 18 years old)
- your "letter of acceptance" from Kaplan confirming the course you are studying

You may need to provide additional documents depending on your circumstances, eg evidence of your:

- previous study, eg academic certificates, references or transcripts
- English language qualifications, eg certificates or awards
- financial sponsor's occupation, income, savings or funds that will support your studies

If you're under 18

You can travel to the UK without an adult but your parent or guardian will need to provide their:

- written consent for you to travel to the UK
- full contact details

They'll also need to provide proof that you have somewhere suitable to live during your stay in the UK, including:

- the name and date of birth of the person that you will be staying with
- an address where you will be living
- details of your relationship to the person who'll be looking after you
- consent in writing so they can look after you during your stay in the UK

When travelling to the UK with an adult you will need to identify them in your visa application. Their name will appear on your visa, and you'll be refused entry to the UK if you arrive in the UK without them. The adult can apply for a visa at the same time, but you must each complete separate application.

You will need to provide original & certified translations of any documents not in English. Please remember you have obtained your visa to study a course in the UK and will be expected to return home once you have completed your course
